METHODOLOGICAL DEVELOPMENTS IN MONITORING MISUSE OF MEDICINES THROUGH GENERAL POPULATION SURVEYS (GPS)

- Project conducted during 2017
- Objective of the project:
 - to develop a common revised module of the European Model Questionnaire (EMQ) with a set of items on misuse of medicines, in order to collect data on the misuse of medicines among general population at the European level



SPECIFIC AIMS OF THE PROJECT

- To conduct GPS mapping exercise (collect questionnaires and methodological procedures from EU countries as well as from the US and Canada)
- To revise the conclusions concerning GPS indicator in a report 'Audit of the EMCDDA data collection tools on misuse of medicine' from 2012
- To organize a workshop during the GPS Experts' meeting in 2017
- To develop a draft module on misuse of medicines



RESULTS FROM THE GPS MAPPING EXERCISE

- 28/30 countries (EU countries + Norway and Turkey)
 responded to the query (Does your questionnaire include questions concerning pharmaceuticals / misuse of medicines, non-medical use of prescription drugs etc.?)
- 10/28 countries had included questions about misuse of medicines in their previous surveys (Bulgaria, Cyprus, Finland, Greece, Hungary, Lithuania, Poland, Spain, Sweden, UK)
 - Themes: Non-medical use/misuse, motivation for use, the use with alcohol, obtaining the medication, problematic/dependent use, use of prescription drugs, other
 - 2 countries (Estonia and Slovenia) were planning to include questions about misuse of medicines in their next survey

RESULTS FROM THE GPS MAPPING EXERCISE

- Questions used varied significantly between countries
 - By definition:
 - prescription-only painkillers that were not prescribed for you
 - sedatives/tranquillizers without a doctor's prescription
 - sedatives or tranquillizers available on prescription only without doctor's recommendation
 - tranquillizers which was NOT prescribed to you by a doctor
 - prescription drugs used for a non-medical purpose
 - By medicines included
 - sedatives/tranquillizers, painkillers
- Variation how widely the misuse of medicines was surveyed from pply one to several different questions

CONCLUSIONS FROM THE GPS MAPPING EXERCISE

- Although there is no module for the misuse of medicines in the EMQ, one third of the countries is collecting data about the phenomenon
- Questions about the misuse of medicines in different surveys and countries lack comparability
- Almost impossible to form an overall picture about the misuse of medicines at the European level with the existing data



PROPOSED EMQ MODULE ON MISUSE OF MEDICINES

- 'Non-medical use of prescription drugs' instead of 'misuse of medicines'
- Benzodiazepines, opioids, stimulants (available on prescription only)
- Six core questions and six voluntary questions example from benzodiazepines



INTRO

NON-MEDICAL USE OF PRESCRIPTION DRUGS

Next questions concern medicines that are sold in pharmacies with a doctor's prescription only. Sometimes these medicines are used without a prescription and in ways or amounts that are different from the usual medical practice.

NON-MEDICAL USE OF BENZODIAZEPINES

Benzodiazepines (such as *diazepam* – *list of trade names®*, *temazepam* – *list of trade names®*, *or...*) are sedatives, tranquilizers and sleeping pills available on *prescription only*. 'Non-medical use' refers, for example, to the use of these medicines without personal prescription from an appropriate practitioner; on larger doses, for longer period, or for different purposes than prescribed.
